

RESOLUTION NO. 2016-07

A RESOLUTION APPROVING A MEMORANDUM OF AGREEMENT  
BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION  
AND THE CITY OF DeFUNIAC SPRINGS, FLORIDA.

**WHEREAS**, the City of DeFuniac Springs (City) and the State of Florida Department of Transportation (FDOT) proposes to enter into a traffic signal maintenance and compensation agreement for the maintenance and continuous operation of traffic signals and devices located within the jurisdiction of the city limits of DeFuniac Springs which consists of State Road No.10 (U.S. Highway 90), State Road No. 83 (U.S. Highway 331 South, in Walton County, Florida: and

**WHEREAS**, the Department and the Maintaining Agency on July 1, 2015 entered into a Traffic Signal Maintenance and Compensation Agreement ("Agreement").

**WHEREAS**, Resolution 2015-11 only provides for a one year term for the agreement and shall be repealed with the adoption of Resolution 2016-07, and

**WHEREAS**, the Parties have agreed to modify the Agreement on the terms and conditions set forth herein.

**WHEREAS**, it is determined to be in the public's interest for the City of DeFuniac Springs to continue to maintain the traffic signal intersections in the corporate city limits; and

**WHEREAS**, the proper maintenance of the traffic signals under the Florida Department of Transportation jurisdiction within the corporate city limits of the City of DeFuniac Springs enhances community safety.


**NOW THEREFORE**, in consideration of the mutual covenants in this Amendment, the Agreement is amended as follows:

All the terms and conditions of the Agreement are superseded and replaced in their entirety by the terms and conditions contained in Attachment "1", Revised Terms and Conditions for the Traffic Signal Maintenance and Compensation Agreement, attached to and incorporated into this Amendment.


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DeFUNIAC SPRINGS, FLORIDA, THAT:**

1. An Agreement dated July 1, 2015, a.k.a., - Traffic Signal Maintenance and Compensation Agreement for FY 2016-2017 between the City of DeFuniac Springs, Florida, and the Florida Department of Transportation is hereby approved for a period of twenty (20) years beginning on July 1, 2015 and ending on June 30, 2035.
2. The Agreement to include Exhibit "A" is in the amount of \$34,048.00 and is for various intersection locations throughout the City of DeFuniac Springs.
3. That Robert "Bob" Campbell, Mayor, is hereby authorized and directed to execute and deliver the Agreement to FDOT.
4. A certified copy of this Resolution will be forwarded to FDOT along with the executed Agreement.
