### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DeFUNIAK SPRINGS, FLORIDA SETTING FORTH INITIAL FINES FOR CODE ENFORCEMENT

**WHEREAS**, a Public Service Announcement was sent out May 8, 2017 notifying the public that citation use would begin May 15, 2017; and


