

A RESOLUTION OF THE CITY OF DEFUNIAK SPRINGS ADOPTING FACILITY RENTAL FEES FOR NON-PROFIT AND OTHER GOVERNMENTAL ORGANIZATIONS USE OF THE CIVIC CENTER, CHAUTAUQUA HALL OF BROTHERHOOD AUDITORIUM, AND JOHN V. LAWSON AMPHITHEATER.

WHEREAS, the DeFuniak Springs City Council wishes to adopt the proposed fees for the use of city facility buildings of the DeFuniak Springs Civic Center, Chautauqua Hall of Brotherhood, and the John V. Lawson Amphitheater.

WHEREAS, the DeFuniak Springs City Council may waive a city facility building rental fee for non-profit organization or other governmental entity for their use.


WHEREAS, the non-profit organization or other governmental entity shall pay a minimum fee to cover employee and other cost incurred by the City of DeFuniak Springs for the use of the facility as stated in Exhibit "A".

WHEREAS, an additional \$50 will be added to each contract for the rental of the Chautauqua Hall of Brotherhood facility for the expense of an elevator to be installed into said facility.


WHEREAS, an additional \$3 per guest will be added to each contract for the use of the Chautauqua Hall of Brotherhood facility from the day following Thanksgiving through New Years' Eve for the use of the building between the hours of 5 p.m. and 9 p.m. for the annual Christmas Reflections event admittance fee.

WHEREAS, the non-profit organization or other governmental entity rents the Civic Center or Chautauqua Hall of Brotherhood during normal business hours (Monday – Friday) 7 a.m. to 4 p.m. except holidays the fees stated in Exhibit "A" shall be reduced by \$50.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DEFUNIAK SPRINGS PASSED AND ADOPTED, in regular session, on this 10th Day of December, 2012.

(Monday through Friday 4 p.m. to 10 p.m. and anytime on Saturday, Sunday, or city observed holidays)

Amphitheater use with sound system	\$110

A deposit equal to the amount of the rent will also need to be paid. The full amount of the deposit shall be refunded as long as the facility rented is left in the same condition as found.
